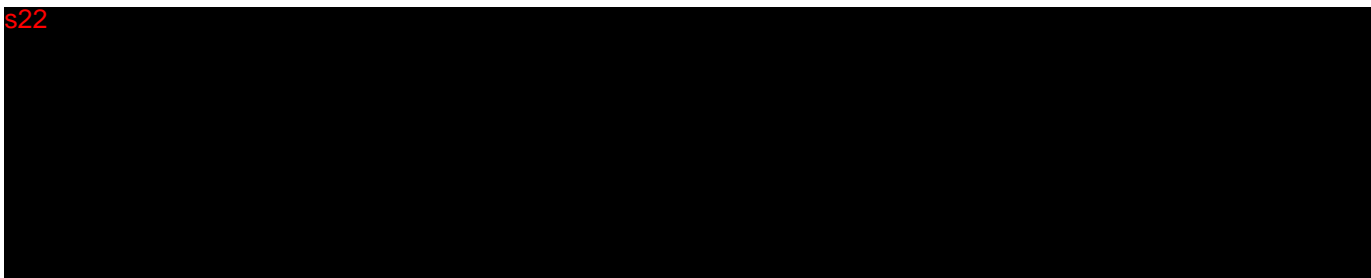

The costs estimated s47F are based on current known associated costs, but due to the nature of the emergency, movement of people, deployment of staff and sub-contractors, reconciliation of all associated

activity and subsequent costs, the costs are an indicative estimate only. More accurate costings won't be known until work orders have been submitted by the contractors and all costs reconciled.
